Morgan Park Summer Music Festival Honors Outgoing Chairman Marge Suozzi

Morgan Park Summer Music Festival (MPSMF) recently held a luncheon in honor of Marge Suozzi, who is stepping down after more than 50 years as MPSMF chairman. Marge will continue to serve on the Executive Committee as Chairman Emeritus and will organize the annual Young Performers Competition, which henceforth will be known as the Marguerite Suozzi Young Performers Talent Competition.

At the luncheon, Marge received kudos from many long-standing members of the MPSMF Team, as well as Glen Cove Mayor Reggie Spinello and the former Mayor, Ralph Suozzi. Tom Suozzi, also a former Glen Cove mayor, and Marge's son, has succeeded Marge as Chairman of MPSMF. Marge, whose husband Joe also served as mayor of Glen Cove, was hailed as Glen Cove's first lady, first mom, first aunt, first sister-in-law and first festival chairman. In addition to naming the Young Performers Talent Competition after Marge, a bench in Morgan Memorial Park to be located near the main stage will be dedicated in her honor.

The day also included a trip down memory lane with a large display of many historic Festival photos and a

Glen Cove graduate honored



The College Sports Information Directors of America have selected Glen Cove High School Class of 2010 graduate Dan Belfiore for the Capital One Academic All-District Division II Football team. This designation recognizes the nation's top student-athletes for their combined performances athletically and in the classroom.

Belfiore, who currently attends Long Island University Post, is a senior defensive lineman with a 3.78 grade-

point average in Accounting and will now be added to the national ballot for the chance to earn Academic All-America notice.

"I was really surprised," Belfiore said. "This is an amazing honor."

Belfiore and his LIU Post teammates captured the Northeast-10 Conference Championship for the first time in nine years. The team's victory led to an appearance in the NCCA Division II Championship, where the team unfortunately fell to Virginia State.

Prior to playing at LIU Post, Belfiore played three seasons at Glen Cove High School, leading the Knights to the playoffs in 2007 and 2008. He was also named All-County, second team All-Long Island and third team All-New York. Additionally, he received the Kava award in 2009, given to someone who encompasses commitment, team spirit, integrity and discipline. According to Glen Cove Football Coach Pete Kopeky, Belfiore was the "hardest working student" he ever coached.

Belfiore also wrestled and competed in track and field at Glen Cove, earning All-County as a shot putter.

cake, designed by Katherine Rezza, in the shape of the Morgan Memorial Park stage.

At the conclusion of the luncheon, Marge officially passed the baton of leadership to the new chairman, Tom Suozzi. The historic antique framed baton had been given to Marge and Joe by Laura Pratt in 1965 as a token of gratitude for bringing MPSMF and the gift of music to the community.

Under Marge's leadership, this past summer marked Morgan Park Summer Music Festival's 55th year of providing free concerts to the public. During that time, MPSMF has grown from hosting one concert in the summer of 1959 to now offering concerts every weekend during July and August. The shows are completely funded through generous donations from businesses and individuals. Taxpayer money is not requested nor received to bring high

caliber talent to the park each year.

Concerts were originally held under Morgan Memorial Park's charming and iconic gazebo; however, this location proved to be inadequate for some of the larger concerts. Consequently, Marge and a team of volunteers raised the funds and oversaw the construction of a beautiful new stage that now serves as the home venue for MPSMF as well as other park performances. Noted Glen Cove architect, the late Norman Dorf, who served as project manager for the 1982 restoration of the New York Public Library donated his time and talent in designing the new stage. Like MPSMF, the planning and construction of the stage was funded entirely through private donations. Marge's leadership and commitment have assured that generations to come will be able to enjoy many evenings of musical entertainment under the stars.

Glen Cove High School Youth Took Action On The Great American Smokeout To Advocate For Change

The Great American Smokeout is an annual reminder that quitting smoking is critical for good health. Sadly, the most at-risk populations in New York haven't been able to quit on this day or any other. The use of Tobacco is still the leading cause of preventable disease and death killing nearly 24,000 New Yorkers every year and afflicting nearly 600,000 New Yorkers with serious disease directly attributable to their smoking. Tobacco is not an equal opportunity killer – there has been no reduction in smoking rates among low-income adults, adults with poor mental health, and those with less than a high school education.

The School Committee of the SAFE Glen Cove Coalition continued their partnership with the Tobacco Action Coalition of Long Island (TAC) to address these concerns on a two week campaign starting on Thursday November 20th in celebration of G.A.S.O at the Glen Cove High School with students by bringing their attention to reducing their exposure to Tobacco Marketing. The Coalition is Co-Chaired by Anthony Gallo, GC HS Health Education Teacher and the School Committee is chaired Denise Kiernan-GC SD Director of Health, Phys Ed & Athletics.

Executive Director-Dr. Sharon Harris said, "SAFE's goal is early intervention and prevention education". Per Carol Meschkow-TACLI Nassau Project Coordinator, "Pharmacies are Licensed health care facilities and unfortunately the sale of tobacco products send an incongruent message to our youth. It's

imperative to reduce youth exposure to tobacco marketing at the point of sale."

After several years of the partnership between the School Committee and TAC this year the youth in coordination with their advisors decided to expand their one day celebration to a two week awareness campaign to educate and solicit support from faculty, parents and peers for the need to ban tobacco sales in pharmacies. Per the American Heart Association, "the availability of tobacco products in pharmacies legitimizes its use and falsely suggests pharmacists support tobacco consumption". To kick off the two week campaign in honor of GASO the student leaders manned a table with Ashley Ferrufino, Coalition Liaison, with eprevention education materials supplied by SAFE and TAC. The day included a visit from the school newspaper reporter, Isabel Blas and youth photojournalist Aaron Hall. Other health education student volunteers solicited by Anthony Gallo included Michael Blas Giovanni Floro, Aura Rivera, Steven King, Erick Cru, Thomas Gracin, Sophia Zias, Adriana Tzavaras, Angelo Albanese, Meghan Smith Delwin Hernandez, Roselle Cacio, Amanda Ieraci, Shawn Davis and Mary Monahan.

Over the course of the next two weeks the student leaders

distributed post cards supplied by the TAC to petition pharmacies for adults to sign and carried youth banners around the school to motivate their peers to sign, and take a stand to end the sale of tobacco in pharmacies.

To culminate GASO, the students, administration, faculty, SAFE Executive Director, Dr. Sharon Harris, TAC Nassau Coordinator Carol Meschow, and local electorate gathered to view the display of adult and youth signatures collected. The gathering included New York State Assemblyman- Chuck Lavine, Nassau County Legislator- Delia DeRiggi-Whitton, , City of Glen Cove- Mayor

Reginald Spinello, former City Council Trustee- Anthony Jimenez, Athletic Director-Denise Kiernan, Health Teachers- Anthony Gallo, Kim Riso, Principal Allen Hudson, Roseann Cirmigliaro, and Nadine Richards.

SAFE Coalition Implements Peer Mentoring Program

Student Athlete Leadership Team Helps To Bolster Peer Resistance Skills
The Finley Middle School's eighth grade class was recently visited by members of SALT (Student Athlete Leadership Team). SALT members discussed life skills they learned through their participation in after school activities and the impact those skills have had on their later lives. SALT members encouraged middle school students to get involved in after school activities be it sports or other activities that interest them as an alternative to idle time where many negative behaviors begin.

The School Committee of SAFE's Coalition is Chaired Denise Kiernan, Director of Health, Physical Education and Athletics at Glen Cove School District. Kiernan stated "The SALT mentoring program is for students at Finley Middle School to learn about healthy decision making skills while working with student leaders in the High School athletic program who demonstrate positive leadership skills. This program encourages students to become leaders on and off the field." As a part of the presentation, SALT team members lead by juniors Michael Payton and Sara Tenke broke students into small groups to demonstrate the importance of team building activities. This gave students the opportunity to work together to accomplish a common goal. Students responded well to this activity and engaged actively appearing to enjoy it.

SALT members also enjoyed the presentation. Brittany Brown, a senior stated she "enjoys coming and mentoring



younger students" and playing an active role in both her school and community. Brown and her peers believe that by sharing their personal stories they can help younger students learn the importance of perseverance and overcoming difficult obstacles ranging from a sports injury to a difficult class.

SALT members created an open forum to allow eighth graders the opportunity to ask an array of questions from bullying to how to become a member of SALT. Caitlin Brown who serves as the President of SALT emphasized the importance of extending "our knowledge to the youth as student athletes, about healthy lifestyle choices. Not only that but developing a relationship with the

children as positive roles models."

The SALT program will continue to visit the Finley Middle School throughout the year to discuss topics ranging from sportsmanship to the negative effects of alcohol and substance use.

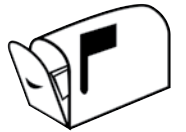

It has evidently become important enough for the mayor to hire a public relations professional, Michael Levy, to help sell this trumped-up bone of contention.

Name the Celebrity



This week's celebrity was born in London on May 23, 1890, the only child of stage actors. Theatrical critics praised his father for his "rich voice", which our celebrity inherited. After a successful theatrical career in the United Kingdom and North America, our celebrity became an in-demand Hollywood leading man, frequently appearing in romantic melodramas and occasional comedies. He may be remembered for his role in Ernst Lubitsch's "Trouble in Paradise" (1932) with Miriam Hopkins and Kay Francis, both which he reportedly romanced during filming. In 1991, "Trouble in Paradise" was selected for preservation by the U.S. National Film Registry by the Library of Congress as being "culturally, historically, or aesthetically significant". He also had roles in Alfred Hitchcock's "Foreign Correspondent" (1940) with Joel McCrea, Laraine Day and George Sanders, in William Wyler's "The Letter" (1940), as Bette Davis' husband, and again as her husband, in Lillian Hellman's film version of "The Little Foxes" (1941).

From 1944 to 1952, he starred in his own radio series "The Man Called X". Often praised for the quality of his voice, he made numerous radio guest appearances and hosted several shows. The actor known for his charm, married five times and periodically appeared in gossip columns because of his sometimes turbulent private life. According to Gloria Swanson's autobiography, they had carried on "a mad love affair" in the 1930's, but he would not divorce his wife, Edna Best. According to Swanson, the void was filled by Joseph Kennedy, a future president's father. Nonetheless, Swanson went to her grave with the sentiment that our celebrity was the most genteel, kind man she ever knew.

During the 1950's and '60's, he periodically performed in historical film's including "The Virgin Queen" (1955) with Bette Davis, the sci-fi culture classic, "The Fly" with Vincent Price and crime thrillers, such as, "Midnight Lace" with Doris Day and Rex Harrison.

Last Week's Celebrity

Last week's celebrity was Ann Doran.

Along with her film career, she guest starred on many TV programs including her role as "Bonnie Landis" in the CBS legal drama, "The Defenders". She appeared in "Crossroads" with J. Carroll Naish and Elinor Donahue and several episodes of "Perry Mason" with Raymond Burr. She was also a cast member of the CBS Saturday morning children's western "My Friend Flicka", as "Mrs. Martha 'Pumpkin' Binghamton", wife of the "Captain" played by Joe Flynn on ABC's "McHale's Navy" with Ernest Borgnine, and the James boys' mother on ABC western, "The Legend of Jesse James". More recently, in the 1970's, she played "Nurse Meg Cratty", who runs an orphanage in Korea and under sniper attack, takes shelter in the medical military camp on CBS TV series "M.A.S.H.". She continued to work in movies and TV until shortly before her death, of natural causes, on Sept. 19, 2000, at the age of 89.

I hope you can help me with my 2015 New Year's resolution. I want to read more worthwhile and enjoyable books throughout the year. Can you start me off with a really good one and, please, not too long....?
Resolute Reader

Dear Resolute Reader,
I have a truly wonderful book for you to begin your admirable quest: Colum Toibin's NORA WEBSTER. Set in an Irish village in the late '60's and early '70's, the novel introduces us to the recently widowed Nora Webster. Her husband, a popular schoolteacher, has just died and Nora is dealing with the many ramifications of this loss. We meet her sisters, her in-laws, her neighbors, and, yes- her enemies, of which there are many because Nora is not an easy person to be around. She has strong feelings of injustice, anger, and guilt. Her family finds her difficult - her mother and she were not speaking when the older woman died, and her children while loving her deeply do not feel at ease with

her. Despite this, the reader comes to admire and like her very much as Nora reflects on her life- whether it be the riots in Derry, her children's schooling, the sale of her family's vacation home, the buying of a new wardrobe, or her annoyance at the mourners who come to her home with sentimental tales of their own losses. Toibin has said this novel is autobiographical with his mother strongly resembling Nora and he, one of the children. While there are no dramatic happenings, by NORA WEBSTER'S conclusion, we feel we better understand ourselves and those around us- quite an achievement!
