#### **V. Committee Reports:**

Gail Carlin, President of the Friends of the Glen Cove Public Library, presented the 2025 Year in Review and outlined goals for 2026.

In 2025, the Friends held a successful book sale and membership drive, gaining 15 new members, and hosted an open house. They participated in the Library's Trivia Night, author visits, Glen Cove's National Night Out, and the Glen Cove Street Fair, and held a plant sale fundraiser. The Friends also organized a Holiday Get-Together, provided refreshments for the Caroling event, and funded the digitization of records and historic newspapers, as well as supporting various children's programs.

For 2026, the Friends plan to start a free-standing library at the Glen Cove train station. Additional goals include hosting another open house and membership drive, holding a plant sale, participating in the Glen Cove Farmers Market, the Glen Cove Street Fair, and Glen Cove's National Night Out. The Friends would like to increase evening meetings to accommodate working patrons, computerize the Treasurer's books, and continue supporting adult and children's programs.
