This summer, their schedule includes in-library visits from Tiegerman School, Glen Cove EOC (Economic Opportunity Commission), and LaFuerza, featuring storytime, crafts, and summer reading/library promotion for students. Off-site visits to Nosh and Connolly School's Extended Year Summer Program also bring storytime and summer reading/library promotion to students and families in the community.

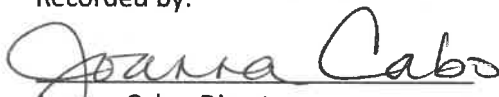
